- Registration categories are as per SAWIS registration.
- Registration give permission for WIETA to access tonnage and litreage off the SAWIS system.
- Registration fees are not dependent on whether the initial or periodic audit has taken place. Once registration has been granted, the registration fee is due each year.
- Failure to settle outstanding annual fees will result in suspension of registration and valid audit assurance letters will automatically be revoked.
- The audit request must be completed within 12 months of initial registration.
- All applicants must participate in WIETA training sessions in preparation for audit.
- Should an applicant wish to cancel their registration they are in their full right to do so and may obtain a Registration Cancellation Form from info@wieta.org.za.
- All access to information is subject to the Protection of Personal Information Act.
